

Stephanie Pickern Northside Garden Club, Klamath District Novice The statue was given to me by a dear friend. The flowers and greenery are tulips.



#7: Creative and clever use of materials. The paper Mache form gives the illusion of a crescent. Although design instructions did not say to use fresh or dried flowers, they are always required in flower shows. The curvature at the top of the design is more emphasized and detracts from a true crescent form and organization of materials on the form disrupts balance.
